

**DECLARATION TO ACCEPT ALTERNATE PLOT AGAINST PREVIOUSLY ALLOTTED NON-

1. I confirm that I am an adult, giving this affidavit with my own free will and consent, without any coercion.
2. I confirm that I have fully read and completely understood the terms and conditions specified in your letter no. _____ dated _____ (the "letter").
3. I, with my own free will and without compulsion, accept and opt for, the new plot number _____ block _____ LDA Avenue - I Housing Scheme, as per terms and conditions of the letter. My earlier agreement for old plot number _____ block _____ is hereby expressly cancelled to the extent of allotment right to that old plot.
4. I state and undertake that all the terms and conditions expressed in the letter are fully applicable to me and must be read as an integral part of this declaration.
5. I understand and affirm that my consent to and voluntarily exercise of the option to avail the alternate plot is irrevocable and cannot be withdrawn or taken back by me subsequently.
6. I state and undertake that by accepting this offer, I have withdrawn all my claims against the previously allotted plot number _____ block _____ of LDA Avenue - I Housing Scheme.
7. I state and undertake that there is no lien or claim of any third party upon previously allotted plot except my own in terms of earlier letter, and Lahore Development Authority or any of its officer/official has no liability nor is bound to honour any transaction conducted by me against previously allotted plot and I hereby expressly declare that such transaction are hereby annulled and cancelled by undersigned. If any such transaction is afterward discovered I would only personally liable to compensate such promise without any recourse or liability of Lahore Development authority.
8. I state that I shall be liable to pay all the financial liabilities i.e. dues, taxes, surcharges and duties e.t.c. as per the schedule of charges as notified by the Lahore Development Authority or any other government functionary.
9. I state that I shall abide by all the building laws, rules and regulations enforced from time to time.
10. I state that I shall not indulge in any sort of illegal commercial activity at the premises.

I further state that if the Lahore Development Authority approves my application and consent for voluntarily acceptance of alternate plot, the plot allocated to me shall be full and final settlement of all claims due to me and shall extinguish in entirety, any claims, rights or grievances I may have against the Lahore Development Authority in this regard. I confirm that I shall not raise or lodge any grievance, claim to entitlement, petition or complaint against Lahore Development Authority or any of its officers/officials at any forum.
