No.SO(H-II)3-9/2014. - In exercise of the powers conferred under section 44 of the Lahore Development Authority Act 1975 (XXX of 1975), Governor of the Punjab is pleased to make the following rules:

1. Short title and commencement.-(1) These rules may be cited as the Lahore Development Authority Tribunal Rules 2014.

(2) They shall come into force at once.

2. Definitions.-(1) In these rules:

- (a) "Act" means the Lahore Development Authority Act 1975(XXX of 1975);
- (b) "assessor" means an assessor of the Tribunal;
- (c) "President" means the President of the Tribunal; and
- (d) "Tribunal" means the Tribunal constituted under the Act.

(2) The word or term used but not defined in these rules shall have the same meaning as in the Act.

3. Qualifications of an assessor.-(1) An assessor shall be:

- (a) an advocate having not less than seven years' practice as advocate of High Court; or
- (b) a retired Government servant, not below the rank of BPS-18, having experience in land related matters and laws.

(2) The Government may appoint an assessor either in full time or part-time basis.

4. Age.- The President and an assessor shall not be more than sixty five years of age on the date of appointment.

5. Terms and conditions.- (1) If a Senior Civil Judge or a Civil Judge of First Class is appointed as the President, he shall be entitled to the same pay and allowances as are admissible to him as Senior Civil Judge or, as the case may be, as Civil Judge.

(2) If a retired District and Sessions Judge or a retired Additional District and Sessions Judge is appointed as the President, he shall be entitled to such pay and allowances as were admissible to him immediately before his retirement.

(3) If an advocate is appointed as the President, he shall be entitled to the minimum of such pay and allowances as are admissible to a Senior Civil Judge.

(4) An assessor shall be entitled to such pay and allowances as are mentioned in the order of appointment.
